A quorum was present. Also present was Mayor Matt Cunningham, David Hummel, Amanda Rowland, and Fire Chief Gary Dizney.

Joey Bailey spoke with the Park Board about putting in 4 benches near the playground to give parents/caregivers a place to sit while watching their children. Mr. Bailey shared that he spoke with Mark Griffith about prepping the ground for concrete for the benches and that the Lions Club will purchase the concrete. He shared that the benches will cost somewhere between \$400-\$1400.00. Motion was made by James Langley to approve the Park benches. Motion was seconded by Scott Ford. UA

Amanda Guinn asked for permission to allow an outside company to bring a miniature pony to the park for her daughter's birthday party. She explained the company has insurance and will also clean up any mess the pony may leave behind. Motion was made to allow the pony in the park. Richard Corum discussed the state of the bathrooms by shelter house #3 and #4 and the high need to renovate and repair damages. The Park Board agreed work needs to be done immediately and requested Ryan Wescoat , City Administrator, to place a bid for local contractors in the paper. Motion to improve bathrooms by Lance Loughridge. seconded by Kevin Dizney. UA

Park operations Discussions
