City Administrator:

Ryan Wescoat, Administrator gave his report. ARPA grants for water meters and Insituform sewer liners are being applied for. Computer software for accounting/water billing demo to be given on July 14, 2022. New email addresses are being personalized for aldermen, mayor, administrator, and staff. City's website and Facebook page are now being updated by the administrator. New grant opportunities for the fire department and police department are to be applied for.
